Thank You, Great Pyrenees!

A year ago, Dr. Gustavo Aguirre, a veterinarian and professor at the University of Pennsylvania, requested Penn-Dutch's help with his research on multifocal retinopathy. He needed Pyr blood samples to help him isolate the gene that causes this disease.

At the Canine Learning Experience in Allentown, PA on January 27, 2007, Dr. Aguirre personally thanked Dr. Dianne Skorup for organizing the Penn-Dutch blood draw, and Wyndhamhill (Virginia) Great Pyrenees Kennel for contributing blood samples from all of their Great Pyrenees.

Wyndhamhill had no affected dogs and was pleased to participate in the multifocal retinopathy research. For further information from this kennel, please contact Joan Ziehl (joan@jmdist.com) or Janet Ingram (jlingram@usit.net).

Dr. Aguirre isolated the gene that causes multifocal retinopathy and has completed his report for publication. His article was accepted for publication in three days from receipt with no requests for any revisions. The article will be published in two months in a veterinary journal and will include an acknowledgement of the help given to him by Penn-Dutch and Wyndhamhill Great Pyrenees.

In addition to helping further our knowledge of canine eye disease, it is hoped that the results of this study may help scientists gain an understanding of similar human eye diseases. Again, a big thank you to the wonderful dogs and their owners for their help with this research!

Board Meeting Minutes, 3/19/05

The meeting was called to order by President Stephanie Unger at 11:45 am. Present were Stephanie Unger, Annette Manwiller, Maureen Simon, Judy Skorup, Karl Edinger, Roslynd Wenrich and John Wenrich.

Minutes from the Board Meeting of July, 2004 were read and a motion was made by John Wenrich and seconded by Annette Manwiller to accept the minutes as presented. The motion passed.

President's Report

* The Canine Learning Experience in January, 2005 at Allentown Fairgrounds was successful thanks to Karl Edinger. We won an Honorable Mention Award at the event for our booth design. There was a good turnout and we disseminated a large quantity of educational materials. Karl sponsored the booth fee as a gift to Rescue.

* The Fort Washington Pet Expo, March, 2005 was also a success due to the hard work of Judy Skorup. We have decided to book the same corner space next year. Cookie sales were brisk and covered the entire cost of the booth.

Treasurer's Report

* The Report was distributed to members. It was reported that Club funds were extremely low. The Board discussed difficulties meeting Rescue expenses as well as general Club funds. Since Rescue is a major portion of Club expenses the Board discussed ways to manage the costs. Options will be discussed at the Membership Meeting to follow the Board Meeting.

* The fact that liability insurance for Rescue has been discontinued was discussed. Maureen will investigate options to replace previous insurance, however insurance may be unobtainable. It was also suggested that a policy be established that all checks received on behalf of the club and/or Rescue be sent directly to the Treasurer. This was moved by Maureen and seconded by John. Annual Meeting Minutes, 3/19/05

The nomination of Gail Hillard was withdrawn because she was not present at the meeting and she had not indicated in writing that she would accept the nomination, as is required by our by-laws.

* Judy Skorup made a motion to vote on the slate with one vacancy. Maureen Simon seconded the motion and

the motion passed.

* John Wenrich made a motion on behalf of the Board to offer the vacant Director position to Gail Hillard, if she is willing to accept it. Maureen Simon seconded the motion and the motion passed.

New Business

* The link to Versatility Dog information can now be accessed through the GPCA website.

Board Meeting Minutes, 2/5/06

The special Board meeting relating to Rescue was called to order at 1:55 pm. Maureen moved that the Board accept written motion #1. Annette seconded. Maureen gave financial report from 3-1-03 to 3-1-06 and she agreed that Rescue go nonprofit because they can solicit funds from places. Maureen wrote to GPCA Rescue and they sent back a letter describing how many clubs are splitting and the GPCA is behind the idea.

Steph said we are a 501, not for profit, not a 501C3, which can be deducted from taxes as a non-profit group. Insurance companies will only insure a 501C3 status group because that assures good financial records for both the status and the record keeping. Maureen said that the 501C3 means also that you can't turn down any members.

We will still support Rescue by raising funds.

Steph wants to hear from all Board members as to what they feel about Rescue.

Steph presented the issue of liability to the Board members if someone has a Rescue Pyr from Penn-Dutch Rescue and has a problem and sues. The membership is not financially and legally liable, only the Board.

Points to remember: Board members can get personal liability insurance, but will new Board members want to run if they have to purchase their own?

Maureen said Rescue costs have tripled in the last 2 years.

Judy is against the motion as written, including the date to begin. What about the dogs already in Rescue? She would like to see this discussed AFTER the National, maybe in May. Has ideas on how to cover expenses. She said we never came up with ideas to cover Rescue monies. Judy has a personal liability policy. Suggested we make an amendment that we take care of the dogs currently in Rescue, but no more. Give Rescue Chairperson guidelines in writing. Judy is afraid that we will potentially alienate Penn-Dutch people who have Rescue dogs and they won't support our National. What will the Club purpose be if we left Rescue?

Steph said according to the Constitution we are NOT a Rescue club and it never was as it began. She said also that we do not abandon the 14 current Rescue dogs we have but that we don't support new dogs in Rescue.

Jay said we are a Pyrenees OWNERS club, not a Rescue club.

Steph wants to include a copy of our Constitution with the next newsletter.

Maureen said that to save money, members can send a self-addressed, stamped envelope with a request for a Constitution or get it off the website.

Judy said that one of the new members (with the pup with the patella surgery) had an issue at the Christmas Party where people said they would never have spent that money on a Rescue puppy. Since we are low on funds, Judy suggests that we send an email to the membership and ask for emergency donations to Rescue because of the need for money. (Our Pyrs are in Rescue longer than usual because of the issue of Katrina dogs being rescued before a breed club dog is rescued). We need money for food and healthcare. Send checks directly to Maureen. Cut off date of March 31? Rescue can give basic vaccines. We set an amount of money (\$300?) on a Rescue dog and that's it.

Maureen wants Rescue to check with Treasurer before Rescue spends any more money on a dog.

Maureen wants to amend the motion that as of 2005/06 Penn-Dutch will no longer support any new dogs in Rescue but we will support the 14 Rescue dogs currently. We will support these until March 31, 2006.

Jay said (1) we will continue to support Rescue dogs (2) we will encourage Pyr Rescue owners to join our Club (3)

we will assist people in acquiring a Rescue Pyr if that's the way they want to go.

Maureen moved that the amendment be changed to substitute the word adoption for placement.

After a lengthy discussion the motion proposed by Maureen and seconded by Annette passed unanimously.

Motion #1: Following the example of clubs such as National Capital Great Pyrenees, Heart of Ohio Great Pyrenees and Garden State Great Pyrenees, the Penn-Dutch Great Pyrenees Club will no longer pick up, transport, house and/or adopt unwanted Great Pyrenees as part of its normal club activities. Since the Penn-Dutch Great Pyrenees Club has no interest in obtaining this specific 501C (3) status, the cessation of the above mentioned activities by the Club will allow those members interested in continuing Rescue endeavors to form their own organization or join with an existing organization.

The Penn-Dutch Great Pyrenees Club will continue to raise funds to financially assist whatever organization(s) will be continuing regional Rescue efforts. The Club will continue to solicit Rescue donations from Club members on their yearly dues renewal form. The Club will also help Rescue by advertising the contacts in the Club newsletter and by publicizing Rescue at Club events such as the Canine Learning Experience and the Fort Washington Pet Expo. If the Rescue organization has items to sell, they will be advertised in the Penn-Dutch newsletter and on the website.

Finally, because of this change, no organization or individual may call their efforts "Penn-Dutch Great Pyrenees Rescue" or imply that they are acting on behalf of the Penn-Dutch Great Pyrenees Club.

Effective Feb. 5, 2006 the Penn-Dutch Great Pyrenees Club will no longer be involved in the pickup, transport, housing and adoption of any Great Pyrenees.

As of Feb. 5, 2006 we will no longer accept any new dogs in Rescue; however, we will support the 12 dogs currently in the Rescue Network until March 31, 2006.

Motion #2:

To put Penn-Dutch Great Pyrenees Club operations in line with Club By-Laws Article 3, Section 2d which states "The Treasurer shall collect and receive all monies due and belonging to the Club," the Membership Chairman function shall be transferred to the Club-elected Treasurer. This is to be effective Feb. 5, 2006.

We discussed that dues should be sent directly to the Treasurer's office. Membership forms will be changed to reflect this new policy.

Discussed revision of the Club By-laws and Constitution. Proposed to accept motion as is by Maureen, seconded by Annette.

We will set up a constitutional and by-law review at Annual Meeting and solicit a new Membership Chair whose role will exclusively be membership. Duties to be specific and to include maintaining a current membership list and membership directory.

The motion passed unanimously.

A motion was made by Maureen to adjourn at 4:40 pm, seconded by Annette.

Board Meeting Minutes, 3/18/06

Elections were held for President by secret ballot. Of the 19 voting members Barbara Bowes garnered 10 votes, Fred Unger 9 votes. Maureen Simon withdrew her nomination for Treasurer and David Kintsfather made the motion to accept Charlotte Powell as Treasurer, seconded by Barbara Bowes. The motion passed.

Calendar

Trophy donations were listed as \$1,895.00. Actual Trophy donations reported in detail sent are \$1,370.00, \$895.00 from GPCA Members and \$525.00 from Penn-Dutch Members. It seems that the \$525.00 for Penn-Dutch Members was added in twice.

* Chair not present. No report.


Nominating and Audit Committee

Cancer in the Great Pyrenees

Overview:

Results from the Health Committee database reveal that cancer is the most prevalent health problem occurring in our breed. The volume of information available on this topic is daunting, and our intent here is to provide an overview of the most common types. This overview will address primary symptoms, diagnosis & treatment recommendations, and current Study & Grant information. We encourage additional investigation on your own.

The most common types of cancer affecting our breed are: Osteosarcoma (bone cancer), which affects the leg bones in larger breeds in 75%-80% of the cases; mammary (breast) cancer, which is most common in unspayed middle-aged bitches but can occur in dogs also; Lymphoma (lymph nodes enlarged and firm); Melanoma (muscle, mouth, toes, behind the eye, or on the skin); Hemangiosarcoma (malignant tumor of blood vessel cells); Meningioma (brain); Lung cancer (usually not a primary site).

The causes are unknown, but research is leaning toward a genetic component, viral causes (e.g., as in Human Papilloma Virus), and environmental links (exposure to chemicals).

Symptoms:

Osteosarcoma: develops deep within the bone and becomes progressively more painful as it grows outward; the bone is destroyed from the inside out. Lameness is usually the first visible sign, and progresses from intermittent to constant over 1-3 months; eventually obvious swelling becomes evident as the tumor grows and normal bone is replaced by tumorous bone.

Mammary cancer: presents as a solid mass or as multiple swellings. Initially these feel like small pieces of pea gravel just under the skin. They are very hard to the touch and difficult to move around under the skin; they grow rapidly, sometimes doubling their size every month or so.

Lymphoma: Typically occurs in middle-aged dogs and bitches that are brought to the vet because one or more lumps have been found. The veterinarian determines that all of the peripheral lymph nodes (those near the skin surface) are enlarged & firm. Usually, the dog has not been showing any signs of illness and the lumps were discovered during grooming, petting, or playing.

Melanoma: can occur in a dog's mouth, toes, behind the eye, or on the skin. Symptoms are variable, depending upon the location, and can include odd color and odd shaped skin lesions, bad breath, loss of appetite, drooling, coughing, weight loss, trouble swallowing, and visible tumors.

Meningioma: a tumor of the membranes which surround the central nervous system, which consists of the brain and spinal cord. The symptoms noted depend upon the brain area involved, but can include seizures (the most common sign), walking in circles, blindness, dragging toes, and ataxia (drunken gait).

Hemangiosarcoma: a malignant tumor of blood vessel cells, this tumor is associated with serious internal bleeding and rapid internal spread. Theoretically, this form of cancer can arise from any tissue where there are blood vessels (anywhere in the body), but the most common are skin & subcutaneous forms, spleen, and heart based. Clinical signs will vary greatly depending on the site of the primary tumor. These can be vague symptoms such as weight loss, episodic weakness, shortness of breath, abdominal distension, ataxia, lameness, blood in the urine, nose bleeds, and rapid heart rate. Occasionally, sudden death will occur with no prior symptoms.

Diagnosis:

Osteosarcoma, by far the most prevalent reported cancer in the Great Pyrenees, can be diagnosed by x-ray as a first step in evaluating lameness. The osteosarcoma is visible in the x-ray as area of bone that has been eaten away (a lytic lesion) and a "sunburst" pattern shows as a corona effect as the tumor grows outward and pushes the more normal bone up and away.

Mammary tumors almost always require a biopsy for analysis and to identify the type. A chest x-ray and physical inspection of the surrounding lymph nodes should also be performed to rule out metastases.

Lymphoma and Melanoma diagnosis usually requires a blood panel and urinalysis, with one or more lymph nodes aspirated and biopsied for confirmation.

Meningioma diagnosis commonly requires imaging of the brain via a CAT scan or MRI. The MRI is preferred over the CT as it is better able to identify fluid build up, swelling or other subtle soft tissue changes inside the brain.

Hemangiosarcoma diagnosis is dependent upon which form is suspected. The skin form requires a biopsy of the tumor (just like Lymphoma and Melanoma); splenic masses are commonly diagnosed upon physical examination and abdominal x-rays or ultrasound exam; heart base forms of Hemangiosarcoma require echocardiography.

Treatment:

Note - Treatment of animals should only be performed by licensed veterinarians after consulting the current literature and treatment protocols.

Osteosarcoma treatment involves two aspects, treating the pain caused by the bone tumor and fighting the spread of the cancer. Osteosarcoma is unfortunately a fast spreading tumor, and metastasis to the lung is common. Although several treatment regimens are currently being used, amputation followed by radiation or chemotherapy appear to be the most often recommended treatment. Median survival times for dogs who do not receive chemotherapy for osteosarcoma is 4-5 months from the time of diagnosis regardless of whether or not they have amputation.

Mammary tumors require surgical removal of the mass unless the patient is very old. If the surgery is performed early in the course of this disease, the cancer can be eliminated in over 50% of the cases. Chemotherapy has not been a very successful nor widely used treatment for mammary tumors in dogs. However, with the constantly changing and improving drugs available, a veterinarian oncologist should be consulted. The effectiveness of radiation therapy to treat mammary cancer has not been thoroughly researched.

Lymphoma treatment is chemotherapy. The stage (I through V) of the disease does not impact upon the response to chemotherapy (i.e., it is not true that a stage II will have a better response than a stage IV). The exception is Stage V, the most advanced stage. Patients with stage V Lymphoma tend to have a poor response to chemotherapy.

Melanoma treatment includes surgical removal of the tumor, radiation to promote shrinking of the tumor, and chemotherapy. The prognosis for Canine Melanoma is poor at best when found in the dog's skin and even poorer when located in the mouth, toes, or behind the eyes. Tumors spread quickly when they are not treated and they may spread even with treatment. The treatment, requiring surgery, radiation, and chemotherapy is expensive and may prolong the dog's life for a short time.

Meningioma treatment involves surgical removal of the tumor and/or radiation therapy. Surgery alone has produced median survival times of 7 months. Radiation can be done instead of surgery or in combination, but what protocols yield the longest survival times is not clear.

Hemangiosarcoma seems to respond best to surgical intervention via removal of the bleeding mass. This intervention seems to provide relief from clinical signs for a period of time, although it does little to improve overall survival, as many times it has already spread by the time it is diagnosed. Chemotherapy has become a principal component in treatment and alternative routes of administration, including inhalation and intra-abdominal administration are being investigated. Immunomodulator therapy (a mixed bacterial vaccine and L-MTP) have also been associated with increased median survival times. Radiation therapy is rarely used; it may help to control clinical signs but has not been shown to significantly improve survival times.

Studies / Grants

Osteosarcoma : Broad Institute - Grant # 373A Mapping Genes Associated with Osteosarcoma in Large Breeds. Funded and supported by the GPCA.

Focus upon genetic risk factors for Osteosarcoma which could be used for the development of genetic tests that could be used to eliminate carriers from breeding populations, eventually reducing the frequency of this disease. Currently a total of 33 samples have been received by the Broad Institute for Great Pyrenees.

10:30 am – Noon: Board Meeting


Noon – 1:30 pm: Pot-luck and socializing

GPCA Longevity Award

The Great Pyrenees Club of America is presenting Longevity Award Certificates to the owners of Great Pyrenees who have reached the age of ten (10) or older. Membership in the GPCA is not required to receive an Award. Any Great Pyrenees whose age can be verified and who has lived to age 10 or greater is eligible for the certificate, if that Pyr is registered with a recognized breed registry of its country. This includes, in part, the American Kennel Club (AKC), the Canadian Kennel Club (CKC), the Federation Cynologique Internationale (FCI) and any other foreign registries that are recognized by the American Kennel Club.

The Longevity Certificate will also be available posthumously. A longevity certificate (LC) number will be assigned to each Great Pyrenees attaining the certification and they will be entered into a database.

Applicants are encouraged to enter any Pyrenees that they have verifiable information for, including those who lived long ago. Verification of the date of birth will consist of a copy of the registration papers from one of the above-mentioned registries. Verification of the date of death or current living status of a Great Pyrenees can be made by getting a written statement from a veterinarian or an active GPCA member in good standing (other than the owner(s) and/or breeder(s) of record). In some circumstances, memorial ads or information from the GPCA archives will be acceptable documentation.
